### 5. Committee terms of reference

Proposed by Cllr M Guilford, seconded by Cllr T Carmichael and **resolved unanimously** to adopt the terms of reference of the committee and recommend these to the Full council for approval, with one amendment.

Standing Orders were suspended as a member of the public spoke re the allotments.

# 6. Allotments and opportunities for produce growth in Haxby

6.1 The Clerk gave an update on the allotments including rents and the waiting list. A request has been made by a resident who lives adjacent to the allotments and requests permission to access their garden through the allotments for a building project.

Proposed by Cllr R Pearson, seconded by Cllr T Carmichael and **resolved** to agree to the request, on the condition that the boundary is returned to the same condition it was prior to the building works and there is no damage.

- 6.2 Proposed by Cllr M Guildford, seconded by Cllr N Wyatt and **resolved** unanimously to agree that,
- 1. Update the agreements and email contact details,
- 2. A budget line for the recording of rental income should be ring fenced
- 3. Two inspections will take place in April / May and Sept / October, each year. This year the inspections will be conducted by Cllr Guildford, Cllr Wyatt, the Clerk and Mr Fitzhugh.
- 4. Judging will take place for the best allotment plot in September for a £100 prize.

Actions for the Clerk – to identify a spare allotment for a community garden.

Action for Cllr Wyatt – A survey of places in the community, suitable for growing.

Action for Cllr E Pearson – An enquiry to York City Council re the old library site, could this be suitable for a community garden?

# 7. Review of a resolution

Proposed by Cllr E Pearson, seconded by Cllr R Pearson, and **resolved** unanimously that the council undertake the white lining on both junior and senior pitches for the 2022 to 2023 season, reviewing the process at the end of the council year subject to the possibility that an alternative way of managing the sports field may be in place.

Proposed by Cllr M Guilford, seconded by Cllr R Pearson and **resolved** with 4 votes for and 1 abstention to agree that a composite three-seater traditional styled bench will be placed in 4 locations throughout the village including the Wyre Pond, Village Green, Ethel Ward Playing field and York Road.

Proposed by Cllr R Pearson seconded by Cllr N Wyatt and **resolved** unanimously to agree that the Ethel Ward Playing Fields pavilion may be used for Haxby playgroups for a jubilee lunch on the 8<sup>th</sup> of June.

The committee received and noted the information.
