A20/2024 Apologies for absence

A21/2024 Chairman's welcome

A22/2024 Declarations of Interest

RESOLVED that there were no declarations of interest under consideration on this agenda other than those already declared in members' respective register of interests.

A23/2024 Public question time and participation

The issue of some overhanging branches on some trees on The Village was raised. The chairman confirmed that this would be discussed at agenda item 9.

A24/2024 Minutes of the previous meeting

RESOLVED to approve and confirm the minutes of the previous meeting held on 3 June 2024.

A25/2024 Ethel Ward playing field and pavilion

a) Netball court - grant application to Sport England

RESOLVED to support the grant application from the netball club to Sport England.

b) Netball court - floodlights

The town clerk reported on problems with accessing the floodlights which should hopefully be resolved soon.

c) Pavilion - fire risk assessment

a) New bus shelters

RESOLVED to note the new bus shelters procured jointly with City of York Council.

b) Bus shelter cleaning

RESOLVED to decline the offer from City of York Council for an alternative bus shelter cleaning service.
