C20 Apologies for absence

Apologies for absence were received from Cllrs C. Hogg, G. Stow, and J. Roberts
RESOLVED to accept and approve the apologies and the reasons for absence.

C21 Chairman's welcome

The chairman welcomed everyone to the second cemetery committee meeting of the new council year.

C22 Declarations of interest

C23 Public question time and participation

No members of the public were present.

C24 Minutes

RESOLVED to approve the minutes of the previous committee meeting held on the 30th of June 2025.

C25 Recent burials / interments

The cemetery clerk reported that in the period 1 April to 30 June 2025 there were thirteen interments consisting of five full burials and eight cremations.

RESOLVED to accept and approve the cemetery clerk's report.

C26 Financial matters

a) Monies owed to Haxby Town Council for Q1 2025-26

RESOLVED to accept and approve payment to Haxby Town Council.

b) Payments since June meeting

RESOLVED to accept and approve payments made up to 31st August 2025.

c) Payments for approval

RESOLVED to approve the cemetery clerk's expenses since July for £20.56.

d) Quotation for procurement of a fireproof safe

RESOLVED to authorise up to the quotation amount received of £1129.70 +VAT plus £189 + VAT delivery charge. The cost to be split 50/50 between Haxby Town Council and Haxby & Wigginton Joint Cemetery Committee.

e) Transferring funds to a higher interest account

RESOLVED to transfer £25,000 from Barclays current account to Skipton Building Society savings account. Cemetery clerk to investigate the market for higher interest rates and prepare a budget for the next tax year 2026-27 which will be discussed at the next meeting.

RESOLVED to approve the request.

c) A request for ashes interment into an existing pre-purchased burial grave

RESOLVED to approve the request.
