8. The Chairman and Cllr Guilford reported back to the Council following a meeting they had attended recently at Oaken Grove Community Centre regarding the youth activities being provided at the centre.

RESOLVED to release the cheque for £9500 to Haxby & Wigginton Youth and Community Association previously sanction as a grant under Section 137. They also agreed that the issue should be discussed further at a future meeting so as to establish exactly what information will be required to support any future grant requests.

### ANNUAL TOWN MEETING

9. The Chairman gave a brief report on the events of the recent Annual Town meeting and focussed in particular on the talk given at the meeting by Andrew Towlerton regarding Neighbourhood Planning.

#### NEIGHBOURHOOD PLANNING

10. Discussion took place as to the next steps to be taken in deciding if Haxby should formulate a Neighbourhood Plan.

RESOLVED that a the Clerk should arrange a meeting for the evening of 27 July 2015 for all those who showed an interest in formulating a Neighbourhood Plan in order to meet and thereby discuss the matter further. The Clerk is to also invite City of York's Martin Grainger to the meeting.

#### HAXBY TOWN SIGN – FINAL DESIGN

11. The final draft of the design for the Haxby Town sign had been circulated to Councillors prior to the meeting and was approved by the Council. Cllr Newton then introduced the concept of having a plaque fitted to the sign explaining the detail within the design. This was also approved by the Council.

### **HAXBY TOWN SIGN - COST**

12. <u>RESOLVED</u> to purchase the sign at a cost of £3845 plus carriage and VAT once planning permission has been received. In addition the Council also <u>RESOLVED</u> to purchase the plaque describing the signs concept at a cost of £60 plus VAT.

<u>RESOLVED</u> that installation of the sign will be administered by the Amenities Committee.

#### **EMERGENCY PLAN FOR HAXBY**

13. Cllrs Rice, Lee and Richardson are to meet in order to formulate an Emergency Plan for Haxby.
