BUDGET OUTTURN FIGURES AT 31 DECEMBER 2013

 The Budget Outturn figures as at 31 December 2013 were copied to each Councillor. The Clerk explained that these had been updated with details of projected income/expenditure for the year ending 31 March 2014. These were received.

FREEMANSHIP OF HAXBY - NOMINATION CRITERIA AND PROCEDURE

 The Clerk presented to the Council a revised draft of the Nomination Criteria and Procedure in line with the comments made at last month's meeting.

<u>RESOLVED</u> to accept the new Nomination Criteria and Procedure as drafted and to insert it on to the Haxby Town Council website.

CITIZENS ADVICE BUREAU

11. The Clerk gave further details on last month's request from Wigginton Parish Council requesting a contribution towards the funding of a second monthly Citizen's Advice session to be held in Wigginton. He also provided the Council with the cost associated with the holding of a session in Haxby as an alternative to part funding the Wigginton session.
RESOLVED that the Clerk is to see if the second Wigginton session could be held in Haxby instead at a cost to Haxby Town Council of £2636 per annum.

TO ADD £5000 TO THE 2014/2015 BUDGET TOWARDS THE COST OF FUTURE RECREATIONAL LAND

12. Cllr Richardson explained that Haxby is short of 64 hectares of recreational land and suggested that a fund be built up for the eventual purchase. He requested that £5000 be added to the 2014/2015 budget for this purpose. A suggestion was then made by a Councillor that a better alternative may be not to add £5000 to the budget but to open dialogue with City of York Council to establish an alternative as to how this extra land may be acquired.

<u>RESOLVED</u> not to increase the budget for 2014/2015 by £5000 and for the Clerk to open dialogue with the City of York Council to see how extra recreational land can be acquired.

2014/2015 SECTION 137 GRANT APPLICATION FROM HAXBY & WIGGINTON YOUTH & COMMUNITY ASSOCIATION

13. The Chairman and Cllr Guilford gave details of their recent meeting with representatives of the Haxby and Wigginton Youth & Community Association concerning their 2014/2015 grant application. After a discussion amongst the Councillors a proposal was put forwarded to make an award of £11000.

RESOLVED not to grant an award of £11000.

Following the failure of the first proposal a second proposal was put forward to make an award of £9500.

RESOLVED to award a grant to Haxby and Wigginton Youth & Community Association of £9500 for 2014/2014 under Section 137.

2014/2015 PRECEPT

14. <u>RESOLVED</u> by a vote of 13 to 1 in favour of setting a Precept figure of £103000 (including City of York grant of £5232) for 2014/2015.

2014/2015 PRECEPT PAYMENTS

 Councillors were advised by the Clerk that the Precept for 2014/2015 will be received in two equal instalments at the end of April 2014 and at the end of September 2014.

NEIGHBOURHOOD PLANNING CAMPS

16. The Clerk gave details of a Neighbourhood Planning Camp which will take place on 23rd-25th March 2014 in York. Attendance, accommodation and food are provided free of charge and each Town/Parish is allowed to send 2 representatives. It was agreed that this item is to be carried forward and discussed again at the February meeting.
